COMPLAINT

IN THE NAME AND BY THE AUTHORITY OF THE STATE OF TEXAS:

Personally appeared before me, the undersigned authority, Kevin Dockery, an Amarillo, Texas Police Officer, hereinafter referred to as Affiant, and who after being by me duly sworn, deposes and says: Affiant has good reason to believe and does believe that LEONCIO PEREZ RUEDA, hereinafter styled Defendant, heretofore on or about the 8th day of July, 1981, and before the making and filing of this Complaint, in the County of Potter and State aforesaid did then and there, intentionally and knowingly cause the death of an individual, namely, Narnie Box Bryson, by strangling her with an object unknown to the Affiant.

MY BELIEF IS BASED ON THE FOLLOWING FACTS:

Affiant has read the Amarillo Police Department offense reports regarding the offense alleged above. The offense reports reflect that law enforcement officers learned the following facts after investigating the offense alleged above: On July 9, 1981, Narnie Box Bryson, hereinafter styled Victim, was found nude and deceased on her bed in her Potter County Texas, residence. There was evidence of genital trauma and several bruises and abrasions on the Victim's body. The autopsy performed on the Victim revealed numerous broken bones and death by strangulation, and confirmed that the Victim had been sexually assaulted.

The bed sheet taken from under the Victim's body was preserved and in 2003, was submitted to the Texas Department of Public Safety Crime Laboratory, where semen was detected and the resulting DNA was analyzed. The unknown DNA was entered into the state and national CODIS data base in early 2004, resulting in the identification of a person residing in New Mexico identified as Leo Perez, aka Leoncio Perez Rueda. In July of 1981, two weeks after the sexual assault and murder of the Victim, Leoncio Perez Rueda was arrested in the act of disorderly conduct, window peeping in the same neighborhood as this homicide. A friend and neighbor of the Victim reported her last contact with the Victim to have been during the evening of July 7, 1981. The Victim never answered her phone calls following that date and time, and an unopened newspaper dated July 8, 1981, was found in the Victim's yard during the investigation.
